SDA CHURCH: Image of the Beast?

Some leaders in the SDA church have come up with crafty and fanciful excuses as to why they have a 501c3. On March 7th 2006 the Bush administration put into law a brand new executive order (# <u>13397</u>) that REMOVES the separation of church and state and forces all churches (with 501C3 status) to become government agencies. Church and State Can Cooperate, Says Pope

VATICAN CITY, MARCH 17, 2005 (Zenit.org).- John Paul II believes that the <u>Church</u> and state can and <u>must collaborate</u> in their service to the person and the common good with relations of "autonomy and difference."

Before getting into the current facts, let's look at the past movements of the beast in Rome to see if there are any parallels. 1693 years ago, in the infancy of Rome's prophecied power we find movements the modern day Vatican can't help but to echo today. 325 AD – His convening of the council of Nicea, which he dominated, on order to secure unity in the church; subsequently, his enforcement of that unity against heretical Christians in favor of the Catholic church.

For all these facts and much more, look into the book written by Philip Schaff called "History of the Christian church" Vol. 3, pp 30-31. Or you can find this data in "Brief bible readings for the home" pp, 367 - 368

Executive Order: Responsibilities of the Department of Homeland Security with Respect to Faith-Based and Community Initiatives

By the authority vested in me as President by the Constitution and the laws of the United States of America, and in order to help the Federal Government coordinate a national effort to expand opportunities for <u>faith-based</u> and other community organizations and to strengthen their capacity <u>to better meet America's social and community needs</u>, it is hereby ordered as follows:

Section 1. Establishment of a Center for Faith-Based and Community Initiatives at the Department of Homeland Security.

(a) The Secretary of Homeland Security (Secretary) shall establish <u>within the</u> <u>Department of Homeland Security</u> (Department) a Center for Faith-Based and Community Initiatives (Center).

(b) The Center shall be supervised by a Director appointed by Secretary. The Secretary shall consult with the Director of the White House Office of <u>Faith-Based and</u> <u>Community Initiatives</u> (WHOFBCI Director) prior to making such appointment. ...

<u>Sec</u>. <u>2</u>. <u>Purpose of Center</u>. The purpose of the Center shall be to coordinate agency efforts to eliminate regulatory, contracting, and other programmatic obstacles to the participation of <u>faith-based</u> and other community organizations in the provision of <u>social and community services</u>.

Sec. <u>3</u>. <u>Responsibilities of the Center for Faith-Based and Community Initiatives</u>. In carrying out the purpose set forth in section 2 of this order, the Center shall:

(a) conduct, in coordination with the WHOFBCI Director, a department-wide audit to identify all existing barriers to the participation of faith-based and other community organizations in the delivery of social and community services by the Department, including but not limited to regulations, <u>rules, orders</u>, procure-ment, and other internal policies and practices, and outreach activities that unlawfully discriminate against, or otherwise discourage or disadvantage the participation of <u>faith-based</u> and other community organizations <u>in Federal programs</u>;

(b) coordinate a comprehensive departmental effort to <u>incorporate faith-based and</u> <u>other community organizations in Department programs</u> and initiatives <u>to the</u> <u>greatest extent possible</u>;

(c) propose initiatives to remove barriers identified pursuant to section 3(a) of this order, including but not limited to reform of regulations, procurement, and other internal policies and practices, and outreach activities;

(d) propose the development of innovative pilot and demonstration programs to increase the participation of faith-based and other community organizations in Federal **as well as State and local initiatives**; and ...

Sec. 4. Reporting Requirements.

... (ii) a summary of the technical assistance and other information that will be available to <u>faith-based</u> and other community organizations regarding the program activities of the agency and the preparation of applications or proposals for grants, <u>cooperative</u> <u>agreements</u>, contracts, and procurement. ...

If you have a 501C3 tax free status, you will be expected to comply with all these "rules and regulations" and any other additions they deem necessary. The government now holds the strings and there isn't thing one you can do about it.

The only way to be removed from a 501(c)(3) status is if the IRS chooses to remove the exemption. So if you dissolve the corporation and continue on as ABC church, an unincorporated church, you're still trapped in their web and under their control." He further testified that **a church is automatically exempt under federal law**

<u>without a 501(c)(3) designation</u>. He also stated under oath that churches request the status just to get the governments stamp of approval. - *THE TRUMPET vol. IX - Issue 6 NOV/DEC 2001*

Why did the pastors fall for this? It's because of greed, plain and simple. If you want to be able to go to the local market to buy "non ministry specific" goods without paying taxes you will need a tax free ID number. Why is the IRS in the business of reading sermons? from THE WALL STREET JOURNAL Editorial Page

When the Rev. George F. Regas delivered a sermon opposing the Iraq War in All Saints Episcopal Church in Pasadena, Calif., two days before the 2004 presidential election, he expected to upset a few members of the congregation. Instead, <u>he seems to have</u> <u>upset the Internal Revenue Service</u>, which began an investigation that is still under way. All Saints <u>isn't the only church to fall out of the good graces of the IRS</u>.

Under the 1954 Revenue Act, 501(c)(3) organizations risk losing their tax-exempt status if they "participate in, or intervene in . . . any political campaign on behalf of any candidate for political office." Over the past two years scores of organizations have faced scrutiny for allegedly mixing their political convictions with their religious ones. And this summer the IRS expanded a program it first launched in 2004 to take direct aim at political advocacy inside houses of worship.

The new crackdown, which <u>the IRS calls the Political Activity Compliance Initiative</u>, has so far put some <u>15,000 nonprofits--mostly churches--on notice</u> that preaching politics puts them at risk of <u>audits, fines or, in some cases, the loss of tax-exempt</u> <u>status</u>. The IRS has also announced it will no longer wait for complaints to come in, but will instead <u>take action "to prevent violations</u>." It will be reviewing the content of sermons, it says, as well as the financial books of religious organizations. <u>The free</u> <u>exercise of religion could now come with a hefty bill</u>.

Antiwar Sermon Brings IRS Warning

<u>The Internal Revenue Service</u> has warned one of Southern California's largest and most liberal churches that it is at risk of losing its tax-exempt status because of an antiwar sermon two days before the 2004 presidential election.

... On June 9, the church received a letter from the IRS stating that "<u>a reasonable</u> <u>belief exists that you may not be tax-exempt as a church</u>." The federal tax code prohibits tax-exempt organizations, including churches, from intervening in political campaigns and elections. The letter went on to say that "our concerns are based on a Nov. 1, 2004, newspaper article in the Los Angeles Times and a sermon presented at the All Saints Church discussed in the article." The IRS cited The Times story's description of the sermon as a "<u>searing indictment of the Bush administration's</u> <u>policies in Iraq</u>" and noted that the sermon described "tax cuts as inimical to the values of Jesus." As Bacon spoke, 1984 Nobel Peace Prize winner Archbishop Desmond Tutu, a co-celebrant of Sunday's Requiem Eucharist, looked on.

Many more articles then this can and have been posted proving as these two prove. Now I agree that we need to keep church & state separate. However, notice the hypocrisy here. In a move that worries civil libertarians, Mayor Eric Kellogg has appointed the volunteer chaplains to comfort crime victims and promote neighborhood activism in the poverty-stricken town of 30,000. Kellogg said the ministers' unpaid duties do not violate the separation of church and state because they do not proselytize. "We're not dealing with separation. We're dealing with collaboration," Kellogg said Wednesday. The American Civil Liberties Union worries that a line has nonetheless been crossed. "Our major concern is that this really amounts to a government promotion of religious values, and a particular religious value," said Ed

Yohnka, spokesman for the group's Chicago office. "When you have a tragedy, there are many people who would turn to their faith. The question is whether government should be sending someone out there to promote their particular faith."

Cardinal Kasper to unveil new work on papal primacy

Vatican, Oct. 11, 2004 (CWNews.com) - Cardinal Walter Kasper (<u>bio</u> - <u>news</u>), the president of the <u>Pontifical Council for Christian Unity</u>, will unveil a new work this week: a book entitled *The Petrine Ministery*, containing the work of both Catholic and Orthodox scholars.

The book, for which Cardinal Kasper served as editor, contains presentations delivered at a May 2003 symposium in Rome. Responding to an invitation from Pope John Paul II (<u>bio</u> - <u>news</u>), who had called for new <u>reflections on the proper exercise of papal</u> <u>authority</u>, the symposium brought together a dozen theologians, equally divided between Catholic and Orthodox, to discuss <u>papal primacy</u>.

Draws From Gospels and Acts of the Apostles

VATICAN CITY, JUNE 7, 2006 (Zenit.org).- Benedict XVI used the Gospels and other biblical passages to explain how Christ entrusted a pre-eminent role to Peter among the apostles, to guarantee unity in the Church. Addressing the 50,000 people gathered today in St. Peter's Square for the weekly general audience, the Pope dedicated a third catechesis to the figure of the fisherman from Galilee, **presenting Peter on this occasion as "the rock on which Christ founded the Church**." "Let us pray," the Holy

Father said, "so that <u>the primacy of Peter</u>, entrusted to poor human beings, may always be exercised in this original sense desired by the Lord, so that it will be <u>increasingly recognized</u> in its true meaning by brothers who are still not in communion with us." -ZE06060705
